

### STATE CONVENTION HOCKING HILLS

I hope you have registered for state convention June 1 - 4 at Hocking Hills. We had our board meeting in February and it was my first visit there. It was a beautiful day and full of visitors even then. The lodge is amazing and I can't wait to go back to explore the area. Don't miss this one! Rooms are going fast so don't put off reserving.

I attended Legislative conference in March. We took a bus from Columbus to DC with 21 of us on the bus. For the first time in a long time retirees were outnumbered by actives.

That is great but since we were there primarily for the bill that eliminates WEP/GPO, that affects primarily civil servant employees and not FERS, I was surprised more were not there to speak up. It does not affect me but I was there. If it pertains to you I suggest you contact your congress person to ask for support of HR-82.

We will be discussing two new issues at state for retirees. One is a change to National Bylaws #1. It will change the body that drives the action and spells out the type of COLA used including the year of the COLA percent.

The second one is #4 that specifies the type of formula to be used if dues are increased. These are stemming from the increase in dues this year. Number one is recommending rejection by the National board and bylaws committee, but are recommending adoption of number four. These will be discussed at state convention but only voted on by the body at national convention in Denver. The full wording is printed in this issue.

Elections for President and Vice President will happen at state convention. I will run again but welcome others to join the race.

Our other main event is in October. Save the date for our fall luncheon at Der Dutchman on October 4th. You will be receiving your invitation in the mail. Denver is the location for National Convention in August. Plan on attending if you can because we will need some assistance manning the booth as we compete for hosting the 2025 convention in Cincinnati Ohio.

We were asked to submit bids for 2025, one because we did such an amazing job before, and also because not many other states either don't want to.

Many states do not have the membership or facilities required to host like we do. Mari Beth and I are stepping up to the challenge along with Fran Brown who has left Kalahari and works for different convention planners.

We are excited to be working together again. Now quit groaning, we have not received the bid yet, and if we do, we are not trying to force anyone who does not want to help, to do so. Retirees have always been great help and I'm sure we will be the backbone of this endeavor. But why you ask?

## Ted Gedeon - Legislative Chair

I would first like thank every Postmaster, Postmaster Retired, Associate Member, spouse and guest who attended this year's Legislative Summit in Alexandria, Virginia. You all did a fantastic job educating and informing our Representatives and Senators about the legislative needs of working and retired postmasters. The message we delivered was well-received and I firmly believe that much was accomplished to further our cause. And to top it off, we had 3 first timers attending!

## The two key issues we advocated were the repeal of WEP/GPO (HR-82) and changing Title 39, extending MPSB Appeal rights to all EAS employees.

One interesting fact we learned in our training was the total repeal of the Windfall Elimination Provision and the Government Pension Offset *would only affect the finances of Social Security 4 hours total*. That is to say if passed, Social Security would run out of money 4 hours earlier than if nothing was done to affect the system. What I found interesting in our conversations was that no one offered any solutions or ideas to put Social Security back on firm financial ground. I guess that can wait for a rainy day... at this writing there are just over 200 co-sponsors of HR-82, with most of our Ohio Reps signed on. 290 is the magic figure to get the bill to the House Floor.

And it was great to have a chartered bus again! Overall it was a fun and successful trip. It is my hope that many of you reading this will consider coming with us next year.

With the re-districting and elections this past November, there are 5 new persons in Congress representing the Buckeye State. Here is the new list of members and their Washington D.C. phone numbers.

**Hiking and Trails**, Hocking Hills boasts 7 unique trails in the hiking areas of the State Park: Ash Cave, Old Man's Cave, Rock House, Conkle's Hollow, Cedar Falls, Cantwell Cliffs and Whispering Cave. Enjoy a fully guided nature hike or hike on your own and be immersed in the beautiful mature forest, surrounded by amazing rock formations, while learning about area geology, history, and the many unique plants and majestic trees.

**Zipline and Canopy Adventures**, Visitors to the Hocking Hills Zipline can explore the treetops during a trip above caves and rock cliffs. Get a bird's eye view of the Hocking River, native wildlife, plants, and rocks. It offers a zip line experience unlike any other in the Hocking Hills. The lines are set over a natural gorge complete with sandstone rock formations, wildlife, and a seasonal waterfall. Our off-road segway guided nature tours showcase the features of the scenic and historic Hocking Hills area. **Canoeing and River Rafting**, Take a break and enjoy the serenity of the Hocking Hills. Paddle the waters once plied by Native Americans and early settlers in the Hocking Hills region. Choose a trip from two hours to two days in a canoe or kayak. Take a leisurely float with a raft or tube. Special outings include Moonlight tours and great beginner's tours.

**Spend a few hours on beautiful Lake Logan**. Enjoy fishing, swimming, sunbathing, and beautiful views of the lake on your very own pontoon boat. Rent anything from Pontoons to Kayaks to Pedal Boats to Paddle Boards on Lake Logan!

**Off Road Tours**, ATV/UTV 4WD rentals in Hocking Hills and Wayne National Forest that offer guided tours on Wayne National Forest. Experienced guides will take you throughout the woods for a half day or full day guided tour. Beginner riders welcome! Bring your own bike to enjoy the mountain biking trails.





## What is Fiscal Stewardship? - Lisa Koprivec Vice President

Some of you may have had someone in your office doing a Gemba and ask you about Fiscal Stewardship. Did you know what it was? Let me give you a little insight.

Most of our reports are now housed in the new Power BI program. You can find this on the Delivery Operations page. (Pathway-Blue page-Delivery Operations (right side near bottom)-Field Operations Support-Power BI) After you pull up Power BI, go to CRDO Line of Sight. Then click the 2 arrows at the top of the left side, this will give you the menu to choose Fiscal Stewardship



Click Fiscal Stewardship, then under that click Unit Level. Now drill to your office.

You will see that this report tells you everything you need to know about the hours in the office and how they are spent.

How much overtime is being used, how much LWOP and FMLA, the office is using. It also lists the sick leave hours, as well as case time, EAS vacancies and supervisor overtime.

This information can also be useful when vetting your next career move. If you want to see the conditions of an office before you apply, or before you interview so that you have a leg up on the competition.
