






This railroad was the first to deliver a letter to the that they Pony Express. Their initial purpose was to separate and prepare the mail to meet the west bound stagecoach. Around the same time, President Lincoln signed the Pacific They were Railroad Act to establish funding for the construction of a railroad from the Missouri River to the Pacific Ocean. Its' main purpose was opening a main line mail route across the western frontier.

By 1880 RPO routes were operating on most of the passenger trains in the U.S. Many American Rail-

roads had very lucrative contracts with the U.S. Post Office Department to carry the mail on highspeed passenger trains. This allowed mail to be delivered in a remarkably short time.

> As many as 12 clerks might be working in a single RPO car at one time. They sorted letters magazines and packages. These clerks were a hardworking group that had to go through in-



"The Country Rebel" GENE STEWART

Gene Stewart, retired Postmaster of Rayville, LA, had a landmark sign unveiled in his honor in Rayville in March, 2023 as a part of the Northeast Louisiana Music Trail. A reception was held and followed by live music.

Although born in Carthage MS(07-21-1938), Gene has called Rayville, La home for over 80 years. He and his parents moved to Louisiana in the 1940's in hopes of a better future, and became tenant farmers in Richland Parish, Louisiana. Through school

Gene farmed cotton and corn with his family but picked up the guitar, singing and writing with his mom and cousins.


While in High School at Holly Ridge, he started a five piece Country/Rockabilly Band called, GENE

STEWART and the "Rockin' Rebels". This was in the Mid-50's and they became requlars on the Twin City Jamboree in West Monroe, LA and the Grand Old Auction Barn in Delhi where he first met James Burton. (Elvis's Lead Guitarist and Band leader until Elvis' Death.)



Upon graduation, Gene volunteered for the U.S. Army (which he viewed easier than the cotton fields). He loves the country and has a great respect for farmers and farming but knew for certain he wanted no part of the farming operation.

While serving at Ft Hood, TX, he played with local



bands and had the pleasure to perform with Clyde "Barefoot" Chesser in 1957 and was billed as "Rock & Roll". In Ulm, Germany, Gene played with German bands and at the N.C.O. (Non-Commissioned Officers Club).

Returning home Gene again formed the "Rockin' Rebels" playing at the Twin City Jamboree at the Fairgrounds Exhibit Building in West Monroe, originally called the Ouachita Valley Jamboree. In 1959 at the Fair Grounds Exhibit building Gene and his band opened for Jerry Lee Lewis. In the early 70's



Gene played regularly at Delta Village, a tourist attraction West of Tallulah, LA, as well as appearing regularly at various country shows, Elk's and Moose Lodges in various cities.

Gene's first recording was "Rub It In" on Camaro Records in Memphis, TN which became a regional hit (recorded 2 years before Billy Crash Craddock's' version became a national THE BAYOU TIMES

hit and million selling record). He recorded several other songs and CD's including "IT'S NOT MUCH BUT IT'S HOME", a song he wrote about his

hometown of Rayville, on the Enchanted Record Label. In 1975 a song Gene wrote and recorded on Enchanted records, "Face of an Angel" was the most requested song on Radio Station K.R.I.H. for that year.




In 1961, Gene began a 42 year career at the U.S. Post Office in Rayville, LA serv-

ing as Clerk/Carrier, Superintendent of Postal Operations, and his last 16 years as Postmaster (serving as OIC in the Tallulah, LA and Monroe, LA Post offices), retiring in 2003. He joined both The National League of Postmasters and NAPUS,

becoming active in the League and serving as State Membership Chairman and later being appointed to the National Membership Committee by National League President, Armando Olvera. Gene excelled at this earning the coveted Membership Blazer more than once. He served on Function 4 detail as Coordinator in the Shreveport MSC as well as Trainer Postmaster. While serving as OIC


before being appointed



Postmaster in Rayville, he was presented a special achievement award by John W Poole, Manager of the Management Sectional Center and Postmaster in Shreveport. Poole said, "the award is reserved for the few who render service far above what is normally expected, demonstrating a high degree of interest and dedication to the job and the postal service."

He also began his Real Estate Career part-time in 1973 and upon retirement from his postal career, became a full time Broker and Investor with his wife, D'Juana, also a Real Estate Broker. He served his community in many capacities including

Kiwanis (President 1989-90) and Jr. Chamber of Commerce member. He was active in the Loyal Order of the Moose, and played many dances and activities in the Northeast area. Gene has been active in his community for many years as a member of Woodmen of the World and is currently in the Chamber of Commerce, a Notary



Public, a member of First Baptist Church of Rayville, LA and a mentor to many young musicians.

Currently Gene continues working some in Real Estate/ Investments and sings at country shows and events as much as possible. He is married to

D'Juana Neal Stewart and together are parents to 3 daughters Terri, Tonya and Apryle, with two grandchildren Madison and Olivia.

THE HONORABLE RETIREES ZONE



Our visit in Washington DC for the **2023 UPMA Legislative Summit** was simply awesome, and the attendance was absolutely outstanding with over 350 attendees! We had the opportunity to hear from the Postmaster General and Chief Executive Officer, Louis DeJoy, National President of NAPS, Ivan Butts; V-P of Government Relations and Public Policy, Peter Pastre; and the Postal Rate Commissioner, Robert Taub.

On Tuesday morning, all attendees came together and were eager to go upon the Hill to visit their legislative aides and policy advisors. Since we were there while Congress was on recess, many of the Senators had to come back to DC to vote on Tuesday, therefore, a few had the opportunity to meet with some of their constituents from their home states. We discussed our position papers with some and educated others about the "Social Security Fairness Act of 2023" (H.R. 82). This bill, which repeals the Windfall Elimination Provision and Government Pension Offset (WEP/GPO), was reintroduced by Louisiana Congressman Garret Graves on January 9, 2023 and seeks fair treatment for civil service annuitants.

While visiting the various offices on the Hill, we talked about the "Postal Employee Appeal Rights Amendment Act of 2023," bill H.R. 595, which Rep. Gerald Connolly (D-VA) sponsored. This bill would extend the right of appeal to the Merit Systems Protection Board to any officer or supervisor, professional, technical, clerical, administrative or managerial employee of the postal service covered by the Executive and Administrative Schedule.

Before leaving each office, it was necessary to mention the status of the *United States Board of Governors* which should consist of nine governors. Two of these governors, Donald I. Moak and William D. Zollars which were appointed in 2020, are now in a holdover period until December 8, 2023, unless someone is nominated, confirmed or appointed to fill these positions before that time expires. It's our prayer those positions are filled!

This Summit was one of the very best I've ever attended and it seemed as if everyone was filled with great anticipation and looked forward to the Hill.

If you missed the Chapter Winter Meeting in Gonzales, you missed a blast! It was such a blessing to

see so many postmasters and managers, retired and active attend. I took the opportunity to conduct a very brief questionnaire among the retirees asking what they would like to see different, or would be interested in while attending the UPMA State Conventions. These are just a few of the responses received back:

Question: What can we do to make your experience much better during our State Convention?

- 1. Recognize retirees more during meetings.
- 2. Retirees are willing to help, so use their help.
- 3. During training sessions for actives, have something retirees can do together.
- 4. In retiree settings, maybe have a separate drawing for retirees only.
- 5. Have something for retirees at our luncheon such as a speaker, door prizes, etc.
- 6. Ask retirees to help out even if it's a minor job.

Thanks to all who submitted a response. We'll be seeking your help during future meetings.

We are anticipating a *Great State Convention* in June, but it's not going to be anything without you! I am asking all retirees and actives around the state of Louisiana, to please consider attending your state convention in Natchitoches. Benny Daigle has already set the stage for everyone to have a beautiful time because of the location we'll be in. Please keep in mind, submit your leave slips, plan a short vacation around this date. There will be guests traveling down to Louisiana from surrounding states. We're also anticipating our **USPS Area Vice President** to be in attendance. The date is *June 15-17th*, the hotel is *Chateau Hotel Saint Denis* in *Natchitoches LA*. We look forward to having a postal family reunion with lots of friends old and new, and many vendors.

Please contact all postmasters, managers, supervisors and craft employees and invite them all to come. Our executive staff will be there to help with any questions or concerns you may have. If you're looking forward to career advancement, this is the place to be to receive the training needed. So, let's make this state convention one that will be remembered for a long time.







SUBJECT: Supervisor Customer Services Workload Credit Update

The Supervisory Workload Credit (SWC) model used to determine the number of Supervisor Customer Services EAS-17 (SCS) authorized in Post Offices has been updated to account for changes in retail and delivery operations.

The SWC model is based on workload factors: it identifies and measures the workload of supervisors in Post Offices, Stations, and Branches. The revisions to the workload model address the challenges expressed by leadership and the management associations through the following modifications.

- Giving credit for Postmaster Reliefs (PMRs) employees.
- Giving credit for Sunday operations.
- Changing the credit for Rural Carrier Associate (RCA) and Assistant Rural Carrier (ARC) from route based to employee count.
- Lowering the ratio for earning the additional Supervisor Customer Services from 35:1 to 15:1
 in large Installations with complex operations.
- Increased credit for Custodians in Post Offices.

The new Supervisory Workload Credit model will go into effect on April 1, 2023.

The SWC staffing tool will reflect the updates with the April posting and can be found on the Workforce webpage at https://workforce.usps.gov/welcome.

A national review of the new earned staffing will be completed by the Field Staffing team. Additional earned SCS will be authorized in the Human Resources system of record effective **April 8, 2023**. At that time offices can establish position numbers and post in the Vacancy Management Tool. There is no need to submit individual staffing requests at this time.


