Adverse Action Legal Defense Plan (AALDP)

EAS with MSPB Appeal Rights:

Adverse Action (Removals/Demotions/Suspensions).......\$3,000 up front. The claimant will be responsible for 25% of the total cost with a \$3,000 maximum cap. UPMA will pay 100% of the additional costs beyond \$3,000 thru the end of the MSPB Initial Decision. Claimant will be responsible for the full cost of appealing beyond MSPB Initial Decision.

EAS without MSPB Appeal Rights (Administrative Appeal under ELM 652.2):

Removals/Demotions/Suspensions......\$3,000 up front. The claimant will be responsible for 25% of the total cost with a \$3,000 maximum cap. UPMA will pay 100% of the additional costs beyond \$3,000.

Eligibility......To be eligible for AALDF benefits, you must be an active EAS member of UPMA for at least one year prior to the date of an initial proposed adverse action. Membership effective date is determined by date Form 1187 is processed at UPMA National Office.

If attorney fees are awarded by a percentage (i.e. 50%), the same percentage will be used when refunding the members used portion of their retainer.

IF YOU RECEIVE A VISIT FROM THE INSPECTION SERVICE OR THE OIG

Statement to be read to Postal Inspectors or OIG:

I request to talk to my UPMA representative before answering any additional questions. If I am a suspect in a criminal matter, please so advise me. If so, I wish to contact my attorney.

If I am under arrest, I request you to so advise me and inform me of the reason or reasons. I will not resist arrest.

I do not consent to a search of my person or property. However, I will not physically resist or obstruct such a search. If you have a search warrant I request to see it at this time.

I will cooperate with you fully, but I will not sign a waiver-of-rights form. I will not admit or deny any allegations, I will not make any written or oral statement unless my attorney and/or UPMA Representative are personally present and so advise me.


got to see who can dance, and those willing to let it all out on the dance floor without a care or shame.

ON THE LEGISLATIVE FRONT



I would like to let you all know the status of House Resolution bill 82. First of all, this is a bi-partisan bill. This bill repeals provisions that reduce Social Security benefits for individuals who receive other benefits, such as pension from federal. state or local governments. This would include civil service retirees. police officers, teachers, railroad workers, and firemen. It is unfairly penalizing civil servants, and this bill would repeal it.

The bill eliminates the Government co-sponsor in the 117th congress Pension Offset (GPO) which in various instances reduces Social Security benefits for spouses, widows, and widowers who also receive government pension of their own. The bill also eliminates the Windfall Elimination Provision (WEP) which sometimes reduces SS benefits for individuals who also receive a pension or disability from an employer that did not withhold Social Security taxes.

Currently it is in the House and Ways committee. Fifteen of the 42 members of this committee are cosponsors. It was introduced back in January by Representative Garrett Graves. We currently have 284 co-sponsors, including all the Loui- bill into law if it reaches his desk. siana representatives, with the exception of Steve Scalise. He was a

but has not agreed to co-sponsor the same bill in the 118th congress. When we get 290 sponsors it is supposed to be forced to the floor of the house for a vote. Contact Representative Scalise's office and urge him to co-sponsor.

There is a sister bill in the Senate, known as the Social Security Fairness Act, introduced by Congressman Ed Markey. This is cosponsored by Congressman Bill Cassidy but not by Congressman John Kennedy. There are 25 cosponsors of this legislation. Contact Senator Kennedy's office and urge him to cosponsor this bill. President Biden has agreed to sign this



Why a UPMA PAC?

UPMA PAC helps elect members of Congress who will support legislation that will benefit active and retired Postmasters and Postal Managers. UPMA is legally permitted to communicate with members of Congress, postal regulators and employees of the Executive Branch, and to provide political education to UPMA members.

However, federal law prohibits UPMA from making campaign contributions to candidates for fed-

eral offices. Membership dues are not permitted for such use. Consequently, UPMA offers its members a means by which they may provide financial support to candidates for federal office. This is achieved through a "separate, segregated fund" known as a political action committee (PAC). A solicitation from PAC discloses to its contributors a clear explanation that the funds will be used for political campaign contributions.


