Finally- You hired a new employee- NOW WHAT?

Training they will need - Orientation is now a 1 day class – We do NOT do any of the required FY training, it is to be done in their station.

CCA- Hired on Saturday. Orientation -1 Day normally. Monday shadow in your office - walk with carrier.

DDC - 8 hour Defense Driving Class. LLV - 8 hr. actual driving - must have driver's license Metris/ProMaster - 4 hr. familiarization. Academy - 4/8 hr. days classroom/mock delivery.

On Job Training - 5 days with certified OJI and *PLEASE return the 1750 to Employee Development. RCA - Hired on Saturday. Orientation - 1 Day - normally. Tuesday shadow in your office - On assigned route * <u>Please give them their LINE OF TRAVEL</u> so the RCA can follow along and make notes.

DDC - 8 hour Defense Driving Class. LLV - 8 hr. actual driving - must have driver's license Metris/ProMaster - 4 hr. familiarization. Academy - four 8 hr. days classroom/mock delivery. On Job Training - 5 days on assigned route.

SSA/PSE - window clerk. It is 52 hours at the SSA academy, then 4 hours last day of academy, 2 hours for study/review, and 2 hours for the exam.

The **On-the-Job Training (OJT)** is a minimum of 24 hours, and a maximum of 40 hours. If it has been determined that the employee is not yet ready to work in the window alone after the initial 24 hours you can extend it to 40 hours.

Postmasters and Managers please stay active in your employees training.

We are trying to Train to Retain.

Your communication with your new employee is key to a successful onboarding and retention.



How to <u>SAVE your JOB.</u> How to <u>NOT get FIRED.</u> How to <u>keep OUT of trouble.</u> <u>Why does my manager HATE me???</u> <u>I can't do what they want me to do.</u>

I would like to think that some (if not all) of the above captions got your attention. Good! I meant to.

Despite all the positive suggestions and training that I know you and all EAS who took on the jobs they are currently in, there are some who for whatever reason, still don't grasp the concept that we all must abide by and that is:

DO THE RIGHT THING ALWAYS and PROTECT YOUR JOB!!!

Some will say that it's easier said than done but let's look at it from a different perspective...MINE. That's right. **MY perspective as a Chapter Member Representative**. I am but one of a team of VOLUNTEERS who have agreed to help, assist, mentor, represent, suggest, PLEAD WITH, and most of all, do whatever we can to keep YOU in your current position.

Nobody forced you to take this job. If they did, call me. Give me a name. But no, I know that didn't happen. So now you are there, maybe for a few weeks, months or even years and one day you get a phone call from your manager who says to you:

Be in my office tomorrow at 10 AM for a PDI.

Well now, that doesn't sound like they are inviting you to lunch does it? No. For whatever reason, they are conducting an OFFICIAL investigation into something for some reason that somehow YOU were involved with. Or for something you didn't do but should have. Sound familiar? I'm not surprised.

Let's be perfectly honest here. If anyone tells me that they complete every single task, every day, without fail or delay and do it perfectly as a Postmaster, Manager or Supervisor then I'm going to tell you to stop lying.

That's right, I said it. <u>I know you don't and so do you.</u> IF you did, you'd be spending about 15 hours in your office every single day. But you also would have about 35 phone calls to answer because EVERYONE wants to speak to the Postmaster about whatever issue they have right? Or the accident you had to investigate that took 6 hours of your time you didn't plan for. Etc. Etc.

So let's put things in perspective here okay? First, I know you have a checklist and you use it every day, right? RIGHT??? <u>If not, get back in the habit of doing so</u>. On that checklist YOU created, be sure to put an asterisk or in BOLD, any task that absolutely needs done without fail to include a time it must be done by.

We call that low hanging fruit. IF you miss those, then chances are, that is a compliance issue you can catch heck for in a PDI and it's called **FAILURE TO FOLLOW**.

If you knew the things I've seen and heard in the last six months alone that folks are getting in trouble for, you would simply scratch your head and ask WHY???? What were you thinking??? You knew better!!!

Quite honestly, I do the same thing. But regardless, IF you made an honest mistake, that's one thing. But IF you intentionally did something that is so blatantly wrong, well then I will tell you now. <u>I can't defend that</u>.

You then ask: <u>"What do you mean you can't defend that or me? I thought UPMA was supposed to</u> represent me, defend me, stand up for me, PROTECT MY JOB????"

Uh, no, that's not how it works. <u>A CMR is NOT a lawyer</u>. We don't do law or defend you especially if you have committed a criminal offense like steal something, like assault someone or go through Express Mail packages looking for money or dope. Sorry, not my job description here. Go call a real lawyer.

Right now, the biggest issue we are seeing that is causing problems everywhere is the SHARING OF PASSWORDS and log in info. Yes I know it's been going on for years and yes I know it was never a problem before. Well things have changed. It IS a problem now, people have taken gross liberties abusing this which is basically an integrity issue and yes, have put money in their pockets they (or someone else) didn't deserve. Falsifying clock rings, putting people in for work hours when they are NOT there, changing AL to SL, etc. is the same as stealing. I can't be any more blunt than that.

Bottom line: DON'T DO IT. I can't defend that.

So you think your manager hates you? Let me see, you call, they don't answer. You email, they don't reply. You text them, you get nothing. This does NOT mean your manager hates you or is ignoring you.

HOWEVER, reverse the rolls here. How many times have you called seeking a solution YOU could have handled yourself or sought advice from another PM? How many emails sent when you were angry? Yes, I've seen some emails that were sent to a POOM (multiple POOMS) that NEVER should have been sent. So think before you hit that SEND button next time please okay?

On another note (and I know this sounds crazy to some) but what have YOU done yourself to offer of your time, expertise or just to say to your manager: I'm here if you need me, OR I can do BLAH, BLAH, BLAH if it will help you out. Try that and see what kind of response you get. You may be surprised.

We've all heard the words "dignity and respect" used over and over. When others fail to do their part (even if it is someone higher than you,) <u>it doesn't mean YOU lower your standards</u>. Take the high ground and set the example, even when things are not going your way. As EAS employees, we get paid to FIND solutions to impossible problems laid at our feet every single day. If not you, then who else will do what is needed?

RULES TO LIVE BY GOING FORWARD FROM THIS DAY

- 1. <u>Do NOT EVER go into a PDI or an Investigative Interview without a representative</u>. IF we are not available at that moment, THEY can wait until we can agree on a reasonable time/date.
- 2. If you are in a PDI, <u>do NOT lie to your manager as they will use it against you</u>. For that matter, your representative needs to the know the truth up front BEFORE we go in. If you lie to us, it stops there. If you screwed up, admit it but don't try to lie about it. Your integrity must be intact.
- 3. <u>As an EAS employee, we are held to a higher standard</u>. Never forget that. If you feel you can't do that, then go put your uniform back on or find another job please. When you lower that standard, you have set yourself up like a bowling pin and will take a hit every time. Some hits you can't recover from.
- 4. <u>IF you have issues (I have issues!!!) get help now. Don't wait to be told or offered EAP</u>. Everyone has been indoctrinated on this yet, some choose NOT to heed this advice. You'll be better in the end.

There will be MORE to come on this topic in future issues so until then, strive to **DO THE RIGHT THING** every day. **And that I CAN defend you on!**
