### Secretary/Treasurer: Kerry Nichols

The first meeting of the new Iowa UPMA board was just last weekend in Council Bluffs. It is always at this meeting where we audit the financial records. I asked new President Greg and new Executive Vice President Sherri to be auditors simply for the fact that they were new to the board. If you have never been a secretary/treasurer or an auditor, it is difficult to imagine how much money moves in and out and how every single penny is accounted for. The audit went well, and they were able to sign off that every item was reconciled. There are always a few checks that have not yet been cashed. We again approved an unbalanced budget for this upcoming year. Last year we budgeted \$20,000 for the state convention. We were pretty close. We spent \$21,348. Next year's convention will be a 3 state convention. Members from the South Dakota and Nebraska chapters stopped by our board meeting for a tour of the hotel and meeting rooms.

Now that those books are completely reconciled, I have written the membership incentive checks. If you receive one, please deposit it. The new board has agreed to continue the incentives for the July to December time frame. You will receive \$100 for a new EAS member and \$25 for each Associate member.

On to some news from the National Office. When we met with DPMG Tulino at our board meeting in January, he mentioned that the special exempt pay when carrying mail was not likely to expire soon. As a matter of fact, he mentioned that he didn't really have a date in mind. As of this moment, the tentative expiration date is October 2023. Quick reminder: if you are swiping the clock because you are carrying mail, you MUST record it in the EAS Carry Survey. Make 100% certain you are contractually sound prior to going out yourself.

For those of us going to the National Convention in Denver, a couple of reminders. Officer training is scheduled on Sunday from 1:30-4:30. This training is not just for current officers. It is a great opportunity to learn what an officer does at the Chapter level. Every year the Iowa Chapter has 3 positions up for election. The Sunday night welcome dinner will be an awards banquet and semi-formal. Thursday night's final banquet will be casual and country and western themed.

One REALLY important reminder if you are coming to Denver. I need your banquet ticket at Monday morning's session if you are intending on dining with us Thursday night. The ticket will be in your registration. If you do not give it to me on Monday morning, you will not have a seat with us. I have to exchange those tickets for numbered seats and tables. If you wish to sit with another chapter at Thursday night's dinner, make sure you give your ticket to that state's Secretary/Treasurer on Monday morning.

## Chapter Member Rep: Words of Advice

First is a **very hot topic**: Due to all of our employee shortages, we may not be able to deliver all the mail for the day, if you cannot safely, make sure you are reporting your offices non-deliveries. You may get berated by your boss (which I hope is Not the case) but that IS the proper protocol given by Headquarters. The protocol is NOT to deliver all mail at all costs, safety should always be considered first, the safety of our Employees AND the safety of us as Managers are equally important. Without our Employees AND without US managers, we cannot function as a <u>UNITED</u> States Postal Service. Follow your SOP for reporting and if you are being berated, contact the Chapter Member Reps, we might be able to help.

Second best practice, and this is one I religiously follow: do you drawer and stamp counts correctly. This means EVERY count is done by 2 people independently, do not falsify the counts just to get off the list, it is not worth losing your job over a butt chewing. Take the time at the beginning of the quarter and count all of your accountabilities, both yours and your clerks. Don't wait until month 2 or 3 and then feel rushed because you are being pressured to get them done. DO THEM EARLY!

A Chapter Member Rep I want to make sure you know when to contact us to assist you in issues.

If you are contacted by your Manager and they want to perform an Investigative Interview with you concerning anything, request representation and call us.

If your manager wants to talk with you, and it's something out of the ordinary, you can ask, can this lead to corrective action against me or may lead to corrective action? If so, ask for representation and call us.

If you are contacted by anyone from the OIG and they want to interview you, ask for representation, and call us immediately.

IF you have been given corrective action, contact us.

Quick Reminder from Edmund:

UPMA Chapter Presidents, UPMA National Executive Board Re: Special Exemption- to deliver mail HRSSC has cut PS-Form 50s effective 12/31/2022, making all Exempt Postmasters 18-22 and all Exempt Station Managers Special-Exempt with a reason code allowing them to allowing them to be eligible for "additional pay when delivering mail." After a long struggle by UPMA, a temporary modification to Postal pay policy will allow select exempt non-bargaining employees to be eligible for additional pay when those employees are needed to deliver mail due to staffing shortages. Based on a UPMA request and conversations at the St Louis UPMA National Convention, the Service has decided to temporarily modify policy and allow employees permanently assigned to the following positions to be eligible for additional pay at the straight-time rate if authorized to deliver mail.

The policy will provide extra compensation for the time a Manager or Postmaster delivers mail, provided the total work hours are more than 8.5 on a scheduled day or any hours on a non-scheduled day. This temporary pay policy is applicable only in those circumstances. Management must meet all contractual requirements before authorizing non-bargaining employees to deliver mail.

This temporary policy commenced on December 31st, 2022, and is now set to end on October 6th, 2023.

UPMA is hopeful this will continue to stay in place until such time as the staffing shortage is rectified. UPMA appreciates this change and looks forward to further discussions with The Service on this and other issues facing our members. This is another example of what can get done when we work together. Please share this with your Area/District Managers as you need to; no further announcement will come from the Service.

## Iowa PAC: Harry Healey

Before I say anything about PAC let me tell about what I was up to a couple weeks ago. For that other Federal employee organization I belong to, NARFE, I was in on ZOOM meetings with legislative aides from both Senators Grassley and Ernst's offices as well as aides from Congress people Hinson and Nunn's offices. Apparently, times couldn't be worked out with the offices of Congress people Miller-Meeks and Feenstra.

We focused on three issues: First, HR 82, the Social Security Fairness Act, which would repeal the Windfall Elimination Provision and the Government Pension Offset which have penalized Federal retirees and the amount of Social Security they receive since 1983. Both Congress people Hinson and Nunn have signed on as co-sponsors to this bill and we thanked them for their support in this issue. The Senate companion bill, S. 597, has not even been considered by Grassley's or Ernst's offices and probably will not get anywhere near their radars until such time as HR. 82 is passed in the House. So, when that happens it will be time to flood their offices with phone calls and emails.

The second issue we discussed was HR. 866, the Equal Cola Act, which, if passed would get FERS retirees a full COLA instead of a reduced COLA in most years. The most that reduction could be in a given year is 1%. Now 1% doesn't sound like much but just like compound interest makes your savings account increase exponentially, compounding a negative also makes that 1% reduction exponentially effect your retirement, but in a negative way. NARFE estimates, based on historical inflation figures, the current law costs the "average" FERS retiree \$7721 after 10 years, \$24,034 after 20 years, and for those blessed to live 30 years into retirement, \$88,282. Since most bills take several years to get passed after being first introduced, if I were a FERS employee planning to retire someday, I would start encouraging my legislators to get serious about this bill NOW!

Lastly, we talked about proposals that have been thrown out that would be detrimental to the earned pay and benefits of all Federal employees and retirees including Postal employees. At our convention in April and also in my last article I mentioned a congressional study group that has made such recommendations. The bad news is that three of Iowa's House members are members of that study group, Hinson, Nunn, and Feenstra. The good news is that they don't have to totally adhere to those recommendations as a whole as demonstrated earlier in this article by support for HR. 82 from Hinson and Nunn.

And that is what our PAC program does for us. It helps us educate our law makers on the effects upon us working people that proposed legislation can cause if passed, both good and bad. It also helps us remind them of our numbers in their districts and that we vote. So, start participating in PAC now and protect what you have earned. Go to http://www.unitedpma.org to get started.



# Seasonal Recipes:

### Zucchini Bread

3 Eggs
1 c oil
2 c sugar
3 tsp cinnamon
1/4 tsp baking powder
2 c grated zucchini
3 tsp vanilla
3 c flour
1 tsp baking soda


